- Please Outline your company's Last five years trade data related to physical wheat trade:
 - Total quantity of physical wheat traded in each year.
 - Origination Country and Loading Port + Destination Country and Receiving Port.
 - Name of the Buyer Organization and Quantity sold.
- Top level audited financial results for last 3 years.
- Please advise your Company Office and Business Unit/Team Name and location in the exporting country that will be responsible for receiving and submitting offers in SAGO wheat tenders. How many staff in this team.
- Please confirm the Official Company Fax Number that will receive Tender Invitations.
- Please confirm the Official Company e-mail address that will receive Tender Supplementary Documents.
- Please confirm the legal structure of ownership of your company/organization clearly for us to understand.
- Please advise the names of all significant stakeholders (+10%) in your organization.
- Confirm your agreement to advise SAGO of any change in significant stakeholder details for your company, such as outright sale or establishment of JV or takeover by another entity.
- Please list any current pending grain or freight trade litigation or arbitration involving your company as a party. Please state where you are the plaintiff or the defendant.
- Please list and provide details any bulk grain vessel loading assets you have a) an ownership stake in, or b) assets under lease to your company, or c) owned/leased under a JV arrangement etc. You may supply your own supplementary document/spreadsheet if you wish for clarity of understanding.
